CPP Increases

Starting 2019, CPP is gradually being enhanced, and the "second additional component" is being phased in 2024/2025. From 2019 to 2023, CPP was gradually raised from 4.95% to 5.95%, but starting in 2024, a second, higher earnings limit is being introduced. Both employers and employees should be aware. CRA My Business Account Receipt Requests

Some colleagues are noticing an uptick in CRA requests for supporting documentation for business receipts as well as increased audit questions. Failure to provide proper documentation to CRA when requested can result in costly denied expenses. Some of the most common areas scrutinized are meals and entertainment, travel costs and vehicle costs. IMPORTANT DUE DATES - INDIVIDUALS AND BUSINESSES

Lots of important due dates to be aware of! This list is not exhaustive but covers many of the more common deadlines:

- September 15th / December 15th / March 15th / June 15th- Personal Income Tax Instalments
- October 31st Underused Housing Tax (UHT) ALL AFFECTED OWNERS such as corporations, trustees or partners owning residential property have to file. This is NOT the same as the vacant tax filing you may have filed with your municipality(see https://www.canada.ca/en/services/taxes/excise-taxes-duties-and-levies/underused-housing-tax.html for CRA's info, or more info from my friends at tax tips here https://www.taxtips.ca/real-estate/canada-underused-housing-tax.htm Note: This is an extended due date for the 2022 calendar year (regular due date April 30th each year)
- December 31st CEBA Loan repayment due; Last date to make donations for 2023 personal income taxes
- February 29th, 2024 Deadline for individuals to contribute to RRSP for 2023 taxation year
- February 29th, 2024 Deadline for businesses to file T4s (wages) and T5s (dividends)
- March 30th, 2024 Deadline to file T3 Trust Return for 2023 IF YOU HOLD PROPERTY IN TRUST FOR ANOTHER, THERE ARE NEW RULES YOU NEED TO BE AWARE OF please see info below as you may have to file for the first time
- April 30th, 2024 Personal Income Tax Filing Deadline (but my clients will remember that I aim to file everything
 earlier!) Note that those who are self-employed can file up to June 15th without penalty, but the tax owing must be
 paid by April 30th to avoid interest charges.
- April 30th, 2024 Underused Housing Tax (UHT) for 2023 ALL AFFECTED OWNERS such as corporations, trustees or partners owning residential property have to file. This is NOT the same as the vacant tax filing you may have filed with your municipality (see links for October 31st deadline above)

Corporate clients should also refer to their "Transmittal Letter" that I provide each year, as it will provide additional important due dates such as corporate tax and HST payments and instalments.

Know your Landlord!

Did you know that if you pay rent to a non-resident of Canada you are responsible to withhold 25% of the amount and send it to CRA? A recent Tax Court of Canada case shows a taxpayer was liable for not withholding tax properly from rent they paid to their landlord residing in Italy.

Do you hold property in trust for another?

In the past, a trust that did not have any tax to pay, such as a "bare trust" (holding property for the beneficial ownership of another) did not have to file a Trust Return. Commencing with the 2023 tax return, that is changing.
